

HOSTEL RULES

1. Visitors, Family Members and Friends are not permitted to stay in Hostel premises.
2. The Hostel Staff can inspect the rooms at any given point time.
3. Students are responsible for the furniture and fittings given to them. Any damage caused to them by the students shall have to be repaired/compensated by the students at his/her own expense.
4. Misuse of Electricity and Water will not be tolerated. Scribbling, spitting, sticking posters on the walls etc. will invite strict disciplinary action against the students concerned.
5. If any student is found involved in any of the objectionable activities, driving without proper documents, rash driving or any act of negligence which may cause harm to others, shall liable to face legal action.
6. The electrical fittings such as tube lights, fans and bulbs in the hostel will be provided only once.
7. Hostellers should take care of their belongings; management is not responsible for any loss, theft or damages of an valuables.

8. The management reserves the right to take any disciplinary action up to the extent of eviction from the Hostel, for violation of any rules and regulations.
9. Hostellers are expected to keep their rooms clean and tidy. Corridors must remain free of all obstacles.
10. Hostellers should be considerate towards one another and refrain from making noise late at night or early in the morning, particularly after 9.30 p.m. and before 6.00 a.m.
11. Drilling, nailing and other works, which may alter/damage/deface the structure of the Hostel, are strictly prohibited.
12. Combined studies with students who are not residing in hostel is not allowed.
13. A Hosteller may appeal to the Disciplinary Committee within 14 days on receiving a Notice of Disciplinary Action against him/her. The decision of the Disciplinary Committee is final and binding to all.
14. The management reserves the right to change and/or introduce any rule/rules without informing the students and their parents.
15. Only pure vegetarian food will be served in the hostel and student cannot demand for non-vegetarian food in the canteen/mess.
16. Intoxicants of any form are strictly prohibited in the hostel otherwise legal action will be taken against the erring student concerned.
17. Outsiders are not allowed inside the hostel.
18. Students have to follow the mediatory time table of mess for food distribution failing with the boarder will be held responsible for his failure.
19. Proper discipline need to be followed by the students while residing in the hostel, playing indoor and outdoor games, taking food in the mess or canteen or using washrooms. Any deviation in the discipline protocol will attract disciplinary action.
